The Clerk and Councillors reviewed a number of 2023-2024 precept options and based upon the approved budget discussed the merits of each option and the impact on both general and earmarked reserves. Councillors recognised that the predicted 2023-2024 general reserves would be lower than in previous years but it was hoped that
